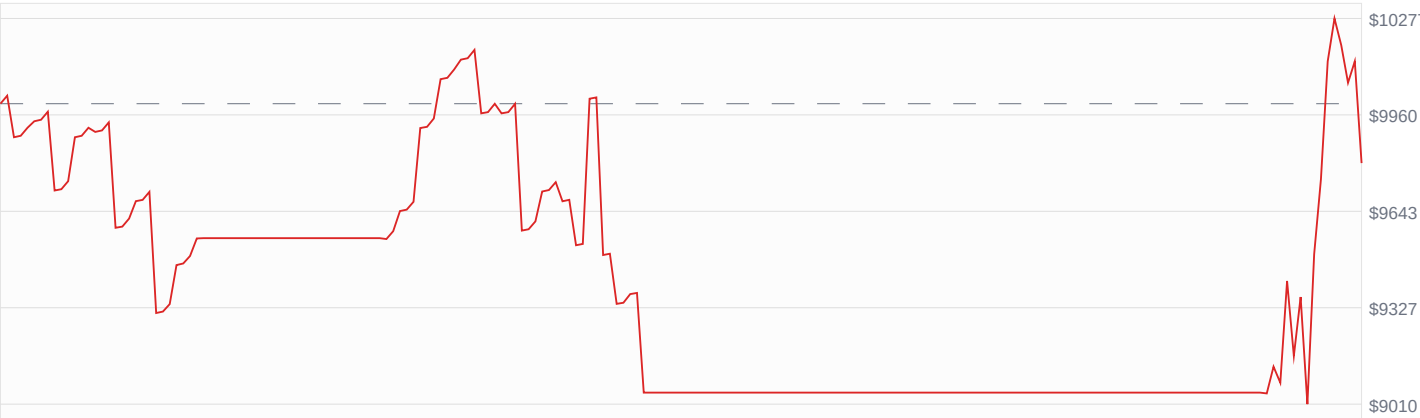

The EVO_EVOEVOEVOE_v1834 backtest on VOXR shows a -2.01% ROI with a 33.3% win rate across only three trades, rendering the Sharpe ratio of -0.05 statistically insignificant. The 11.32% maximum drawdown indicates the strategy failed to capture volatility while incurring substantial drawdown during a tiny sample. Such a limited dataset lacks the robustness required to validate any edge, making current performance metrics unreliable for live deployment. A concrete next step involves stress-testing this logic over a broader historical range to determine if the poor results stem from parameter overfitting or genuine market incompatibility. Until statistical confidence improves through expanded trade history, this approach remains unsuitable for
