The EVO_GG1RSISNIP_v1486 backtest on AAPL shows a +10.70% return driven by only two trades, rendering the Sharpe ratio of 0.87 statistically insignificant due to extreme sample size constraints. While the strategy captured volatility without exceeding an 11.50% drawdown, the 50% win rate offers no predictive edge in a low-frequency regime. We lack confidence in generalizing these results to live markets until we expand the sample through walk-forward analysis or parameter sweeps. The next step is to re-run the test with a rolling window of 60 days to validate if the signal persists under varying market regimes.
