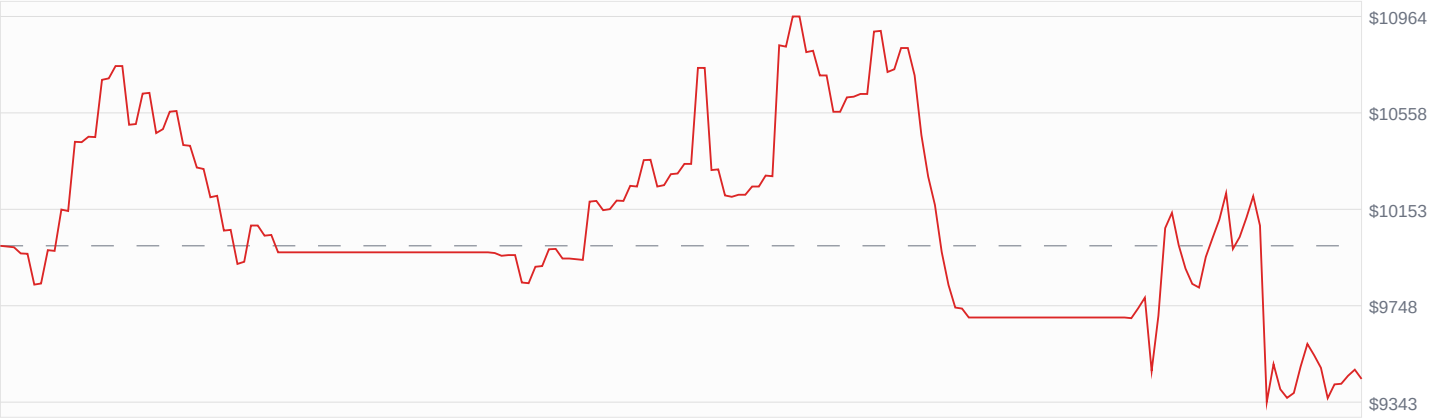

The EVO_GG1RSISNIP_v969 strategy on RDN failed catastrophically, delivering a -5.59% ROI and zero wins across only three trades. Such a tiny sample size renders the Sharpe ratio of -0.31 statistically meaningless and provides no confidence in the signal logic. The 14.78% maximum drawdown indicates excessive risk exposure during a single loss event rather than a systematic alpha generation problem. We must run a longer backtest on expanded data or adjust the entry thresholds before deploying capital. This result highlights the critical danger of overfitting on low-volume assets without sufficient historical validation.
