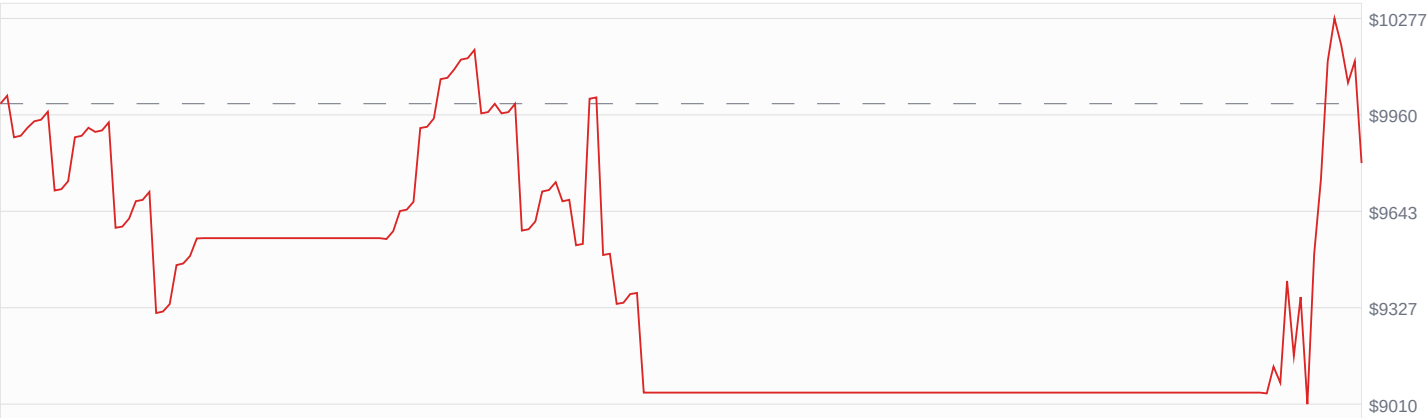

ANALYST NOTE

Hera local LLM

The daily opportunity strategy on VOXR underperformed with a -2.01% ROI and a negative Sharpe ratio, indicating the model lost money on average per unit of risk. With only three trades executed, the 33.3% win rate and 11.32% maximum drawdown lack statistical significance, rendering the results too noisy to confirm a structural flaw. The sample size is insufficient to draw definitive conclusions about the strategy's viability under current market conditions. A prudent next step is to run a longer backtest on a higher timeframe to gather more data points before adjusting entry parameters. This analysis serves an educational purpose and does not constitute financial advice.
