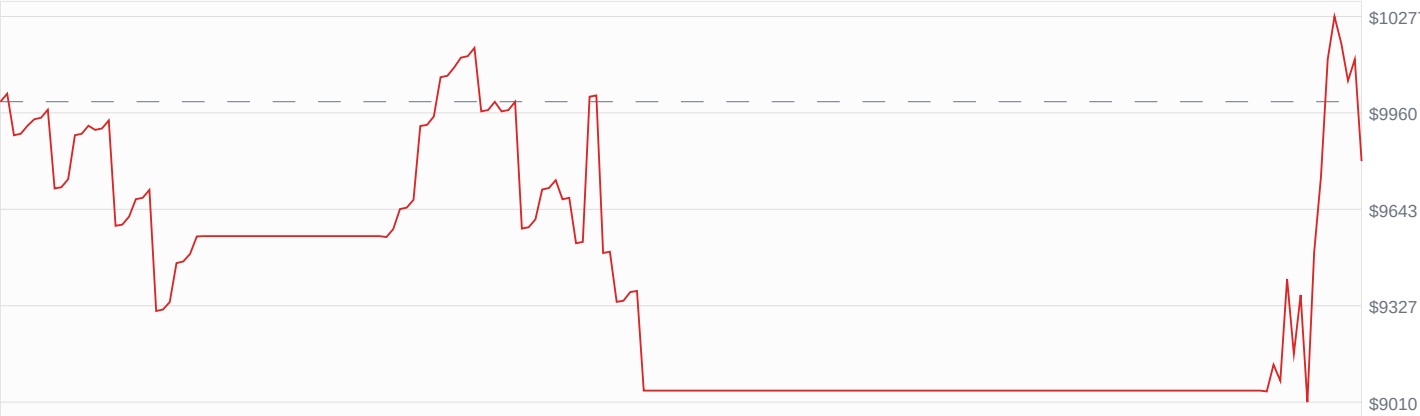

ANALYST NOTE

The EVO_EVOEVOEVOE_v1972 strategy on VOXR failed statistically, delivering a negative ROI and a Sharpe ratio of -0.05 across only three trades, rendering the results statistically insignificant and unrepresentative of the strategy's true edge. The 33.3% win rate suggests a severe structural flaw or a regime mismatch, while the 11.32% drawdown indicates poor risk control relative to the meager trade volume. Given the high variance from such a small sample size, any positive interpretation would be speculative rather than evidence-based. The immediate next step is to broaden the parameter space or symbol set to gather sufficient data for a robust statistical assessment before deploying capital.
