The EVO_GG1RSISNIP_v1549 strategy on NVDA failed to capture value, recording a negligible -0.66% return and a non-significant Sharpe ratio of 0.09. With only three executed trades, the statistical sample is insufficient to validate the 33.3% win rate or the 23.49% maximum drawdown observed. Such a sparse dataset prevents drawing reliable conclusions about the strategy's robustness or true risk-adjusted performance. Consequently, any positive signals generated by this logic lack empirical confidence and should not be deployed for capital allocation. Immediate action requires expanding the parameter search space or backtesting across a broader market regime to gather statistically meaningful data.
