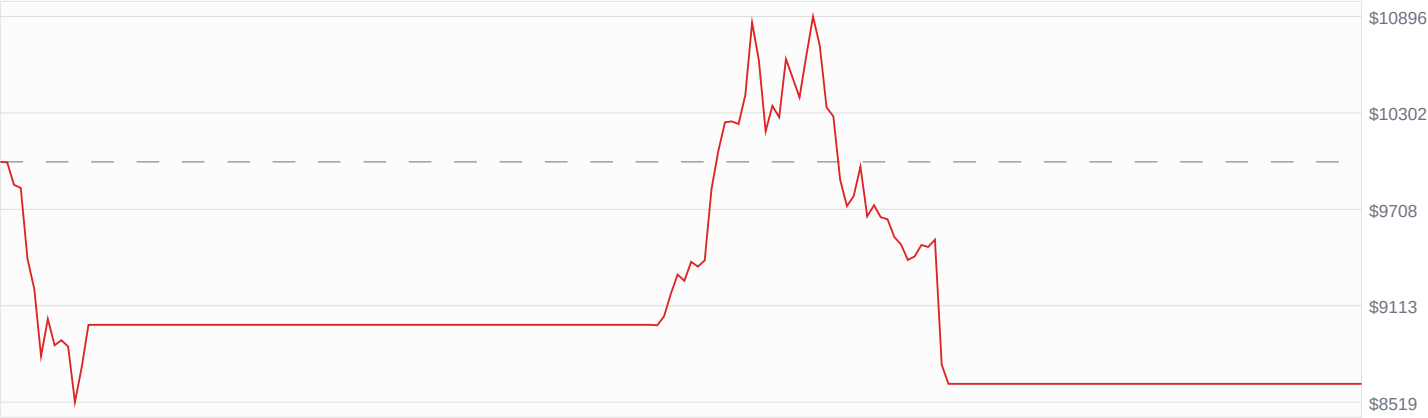

The GG5 Stochastic Oversold strategy on DOGE/USD failed catastrophically with zero winning trades and a 20.78% drawdown, indicating a severe lack of adaptability to the current volatility regime. With only two trades executed, the negative Sharpe ratio of -0.83 is statistically insignificant and offers no reliable predictive power for future performance. Relying on oversold conditions in a trending asset class like Dogecoin often leads to catching falling knives without sufficient confirmation. A concrete next step is to implement a trend filter, such as requiring price above the 200-period moving average, before entering short or long positions. Until the sample size expands and the strategy proves robust across multiple market
