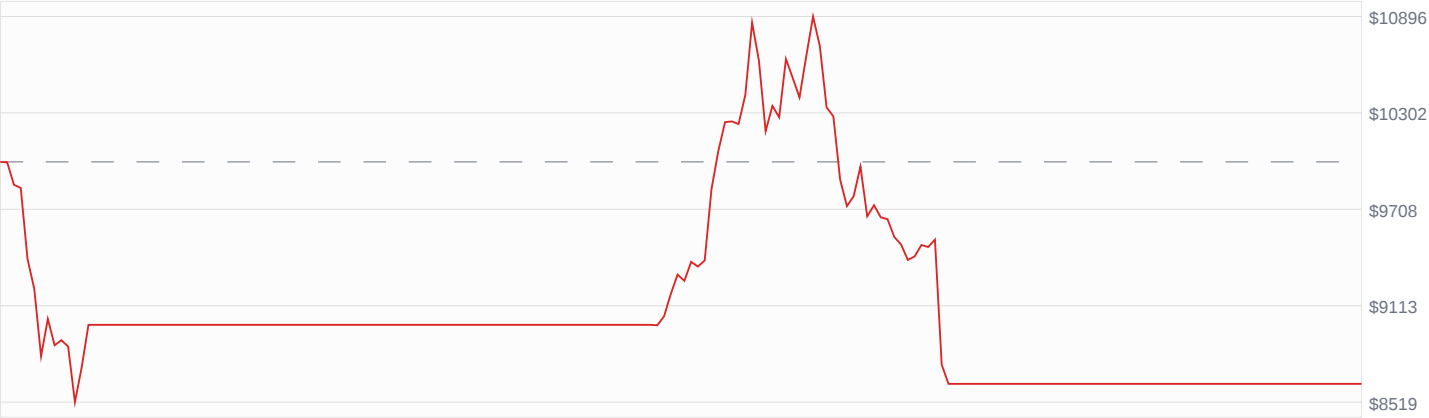

ANALYST NOTE

The backtest for DOGE/USD using the GG5 Stochastic Oversold strategy failed catastrophically, producing a negative ROI of -13.68% and a Sharpe ratio of -0.83. With only two trades executed and a zero percent win rate, the statistical sample is insufficient to validate the strategy's logic or identify execution errors. A maximum drawdown of 20.78% indicates significant exposure to false signals during the test period, rendering the approach non-viable under current market conditions. The strategy likely requires recalibration of entry thresholds or a complete overhaul of the stochastic parameters to filter out noise effectively. A prudent next step is to expand the testing window or pivot to a different oscillator to establish a statistically
