The EVO_EVOEVOE_v1922 strategy on VOXR failed to generate alpha, recording a -2.01% return and a negative Sharpe ratio of -0.05, indicating a loss of capital relative to risk. With only three executed trades, the sample size is statistically insignificant, rendering the 33.3% win rate and 11.32% drawdown unreliable for performance attribution. The extreme low trade count suggests the entry filters were too restrictive, preventing the model from capturing market volatility. We must widen the entry parameters or reduce position sizing thresholds to increase trade frequency before drawing definitive conclusions. This specific iteration requires immediate parameter optimization to improve statistical validity and profitability.
