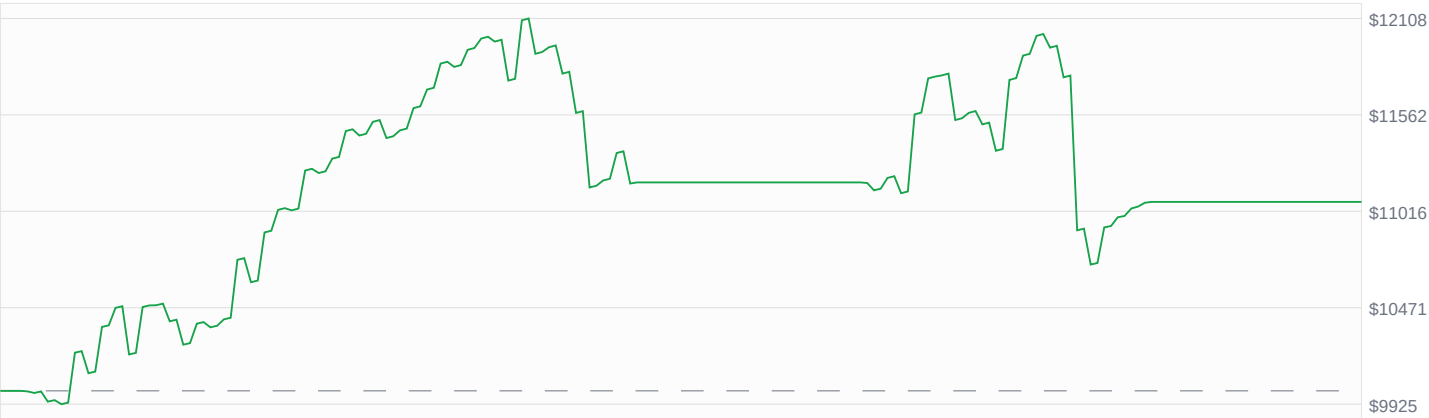

ANALYST NOTE

Hera local LLM

The EVO_EVOEVOEVOE_v2065 strategy on AAPL generated a +10.70% return, yet the sample size of two trades severely compromises statistical validity. A 50% win rate with only two executions offers no confidence interval, rendering the 0.87 Sharpe ratio and 11.50% drawdown metrics anecdotal rather than predictive. The modest ROI suggests the strategy lacks robustness outside this specific short-term window or volatility regime. Without additional trades to confirm edge, the results could easily be noise masquerading as alpha. The immediate next step is to run a longer historical backtest to verify if this performance holds across different market conditions.
