The EVO_EVOEVOEVOE_v2144 backtest on MSFT shows a 20% return, but the strategy executed only two trades, rendering the 50% win rate statistically insignificant. A Sharpe ratio of 1.06 and 14% drawdown suggest moderate efficiency, yet the low trade count prevents any reliable inference of edge or risk profile. We cannot validate performance or generalizability without a larger sample size across extended timeframes. The next step is to extend the backtest window or optimize entry filters to increase trade frequency before deployment.
