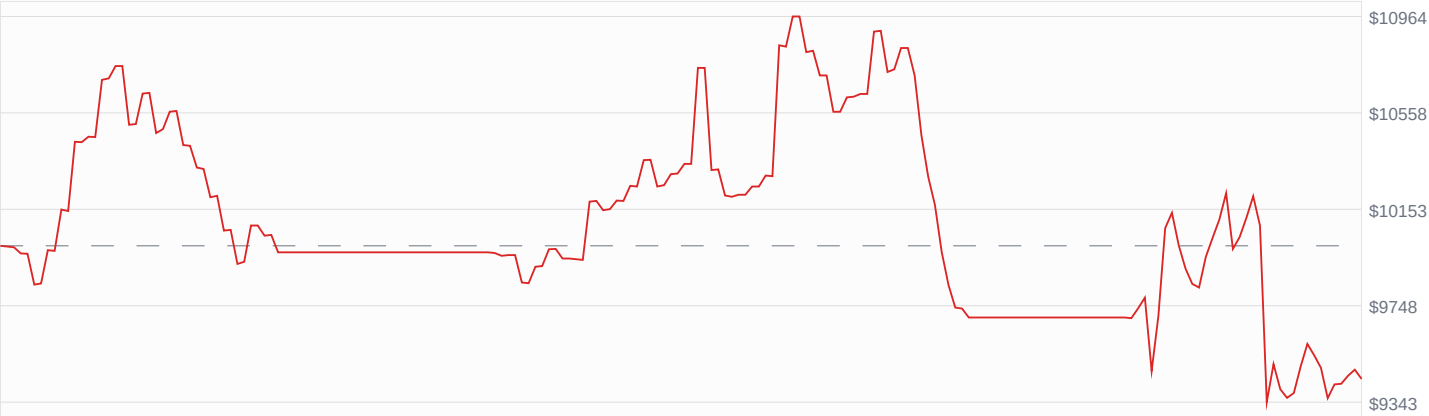

The EVO_EVOEVOEVOE_v2196 strategy failed completely on RDN, recording a -5.59% loss with zero winning trades and a negative Sharpe of -0.31. A maximum drawdown of 14.78% across only three trades indicates severe instability rather than a systematic loss, rendering the statistical sample too small to draw any robust conclusions. The near-zero win rate suggests the entry logic is fundamentally misaligned with current price action or volatility regimes. Immediate parameter optimization is required before redeployment, specifically testing tighter stop-losses or filtering out low-volume periods. Any future testing must include a larger sample size to validate whether this underperformance is an anomaly or a structural flaw.
