The EVO_EVOEVOEVOE_v2187 backtest on BWB shows a 2.15% ROI, but the 33.3% win rate and 13.41% drawdown indicate poor risk-adjusted returns, with a Sharpe ratio of only 0.25. The strategy failed due to excessive false signals, which is expected given the mere three trades in the sample. Such a small dataset lacks statistical power, rendering the performance metrics highly unreliable. The next step is to expand the backtest window to improve sample size and validate strategy robustness before deployment.
