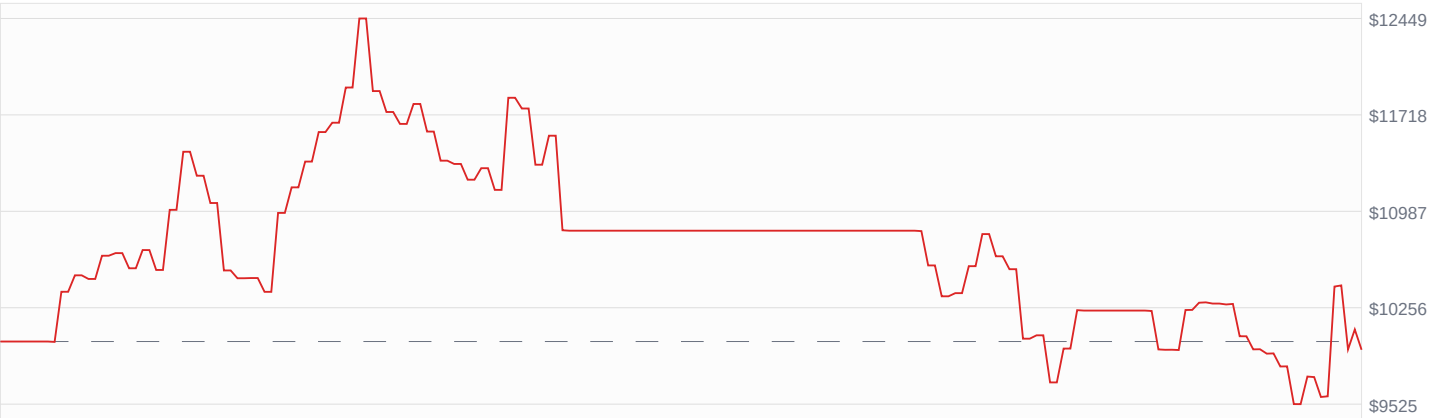

ANALYST NOTE

The EVO_WEBIDEA_v2200 backtest on NVDA reveals a flawed strategy, registering a negative return of 0.66% and a low Sharpe ratio of 0.09. With only three trades executed, the statistical sample is too small to draw reliable conclusions about the system's efficacy. A maximum drawdown of 23.49% indicates significant volatility risk that the current parameters fail to mitigate effectively. The 33.3% win rate suggests the entry logic is likely misaligned with current market dynamics or lacks sufficient filtering. The immediate next step is to backtest the same logic on a longer historical dataset to validate whether these results reflect structural failure or just market noise.
