The EVO_WEBIDEA_v88 backtest on BWB shows a +2.15% ROI but suffers from severe statistical insignificance due to only three total trades. A 33.3% win rate paired with a meager 0.25 Sharpe ratio and a -13.41% drawdown indicates the strategy is currently undercapitalized or overfitted to noise rather than capturing genuine alpha. With such a tiny sample size, these results lack reliability and cannot be used to draw firm conclusions about the strategy's long-term viability. The primary issue is insufficient trade frequency, which prevents the calculation of robust risk-adjusted metrics. The next step is to run a longer backtest on a lower time interval or adjust entry filters to generate a statistically significant trade history before deployment.
