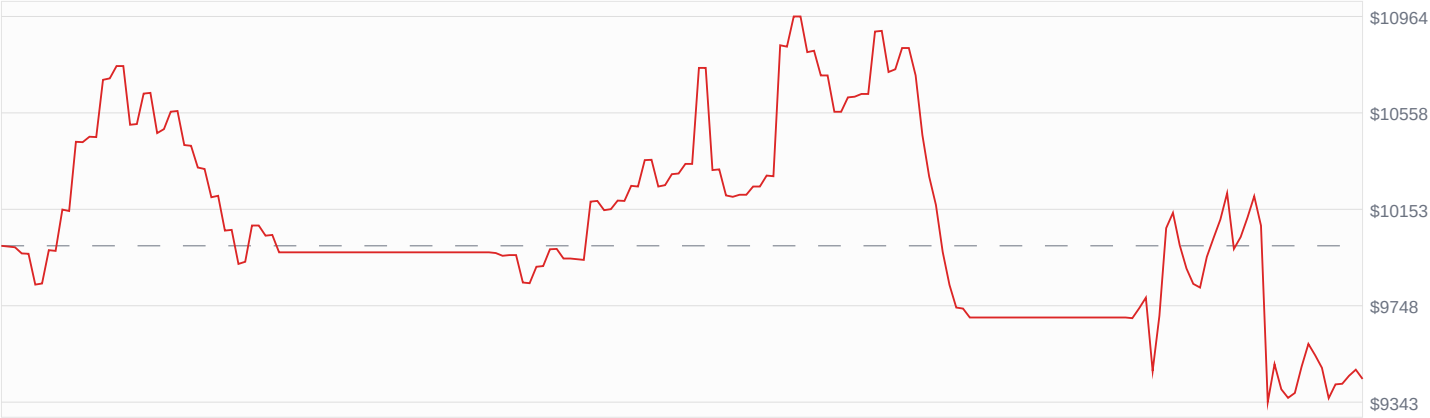

The EVO_GG1RSISNIP_v192 strategy on RDN failed catastrophically, yielding zero winning trades and a -5.59% return over just three executed positions. With a sample size of only three trades, the Sharpe ratio of -0.31 and 14.78% drawdown lack statistical significance, rendering the equity curve unreliable for production deployment. The strategy likely suffered from overfitting or entered a regime where the underlying signal logic was entirely invalid for this specific asset class. We must reject this parameter set immediately and avoid live capital allocation until a larger, positive equity curve is demonstrated across multiple assets. The next step is to run a parameter sweep to identify more robust settings or pivot the strategy entirely to a
