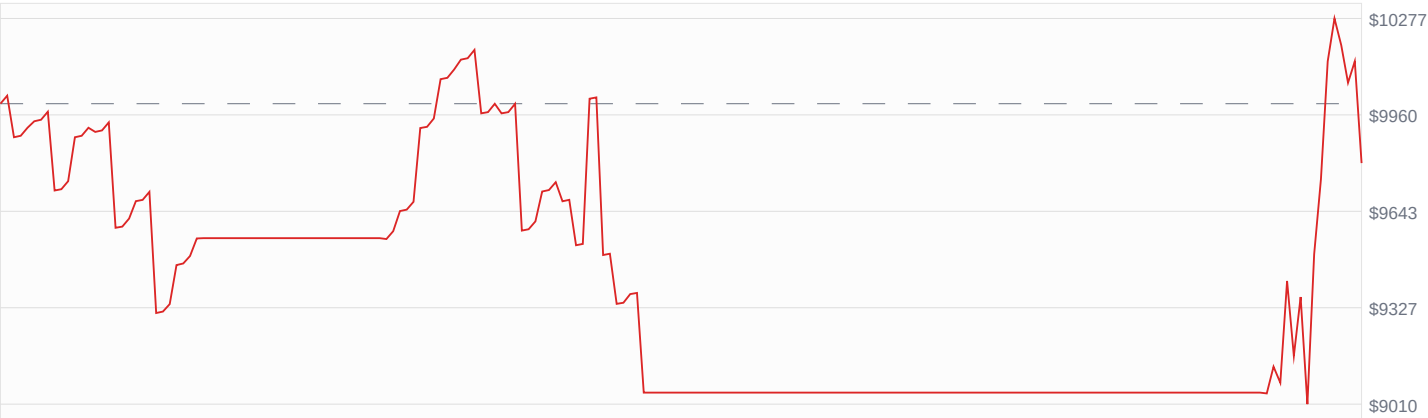

The EVO_EVOVELOCIT_v1524 backtest on VOXR failed to generate alpha, delivering a negative ROI of -2.01% with a non-significant Sharpe ratio of -0.05 due to insufficient sample size. Only three trades were executed, resulting in a mere 33.3% win rate and an unacceptable maximum drawdown of 11.32%, which indicates high instability rather than a clear strategy flaw. Statistical confidence is negligible with such low trade volume, rendering any performance metrics unreliable for live deployment. A concrete next step is to optimize entry filters by narrowing the volatility regime or extending the backtest window to gather statistically significant data points. Until the sample size improves, this configuration cannot be validated for institutional
