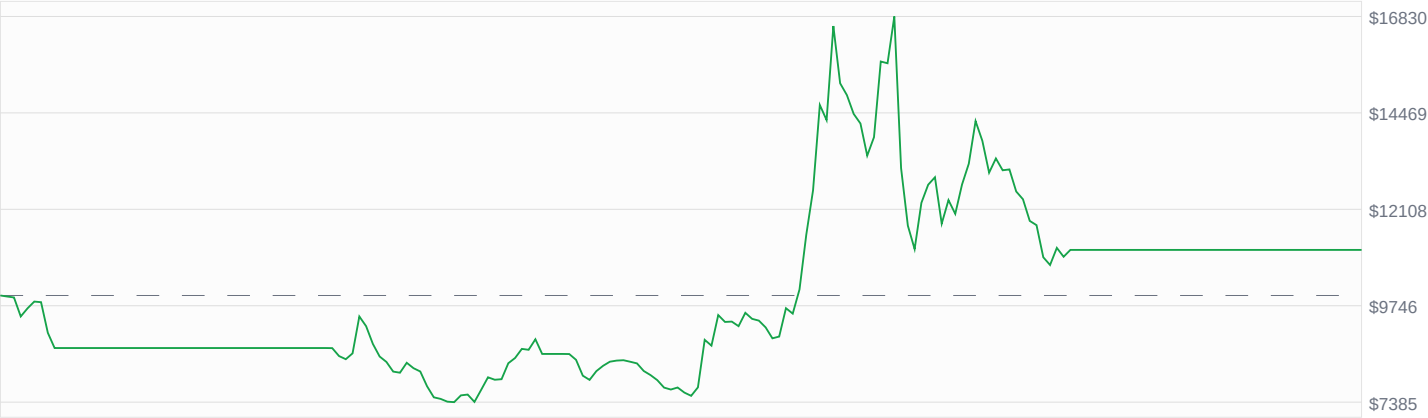

ANALYST NOTE

The NEAR/USD backtest shows a 11.13% return driven by three trades, but a 36% drawdown and 0.52 Sharpe ratio reveal a strategy that is more luck than logic. With only three trades, statistical significance is absent, meaning the 33% win rate is too noisy to trust as a reliable edge. The high volatility suggests momentum signals failed during the specific 24/7 execution window, likely missing context from market hours or news events. Next, re-run the test with tighter entry filters and a minimum trade count of fifty to validate whether the alpha persists outside of outliers.
