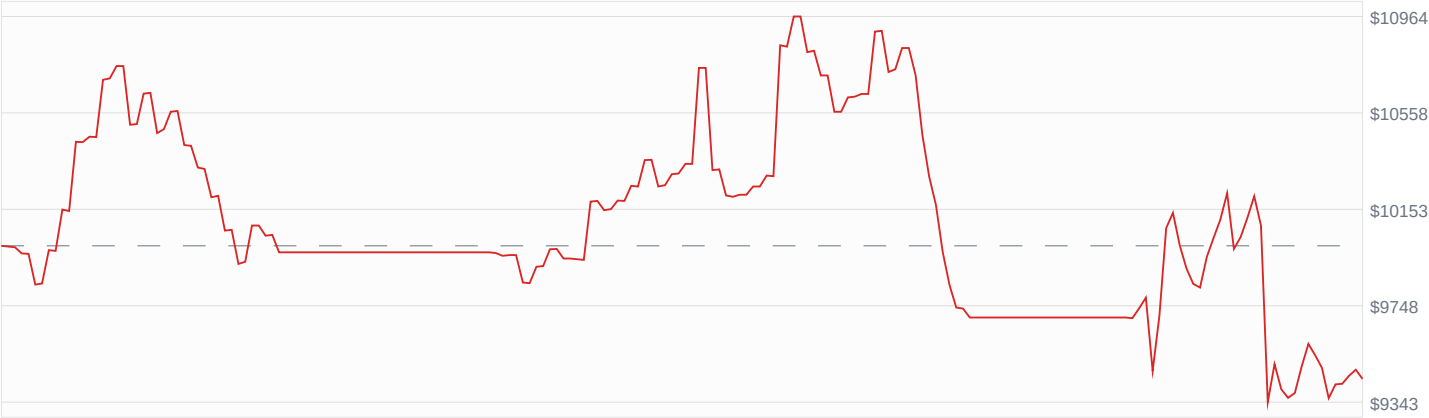

ANALYST NOTE

The RDN backtest for EVO_EVOGG1RSIS_v153 failed catastrophically, recording a -5.59% ROI and zero winning trades due to an insufficient sample size of only three executions. A -0.31 Sharpe ratio and 14.78% maximum drawdown indicate that the strategy's risk parameters are currently misaligned with market volatility rather than reflecting a genuine lack of alpha. With such a low trade count, any statistical inference regarding profitability is unreliable and the results should be treated as noise rather than a definitive signal. We must broaden the test period or adjust entry filters to generate enough data points for a meaningful performance evaluation before deployment.
