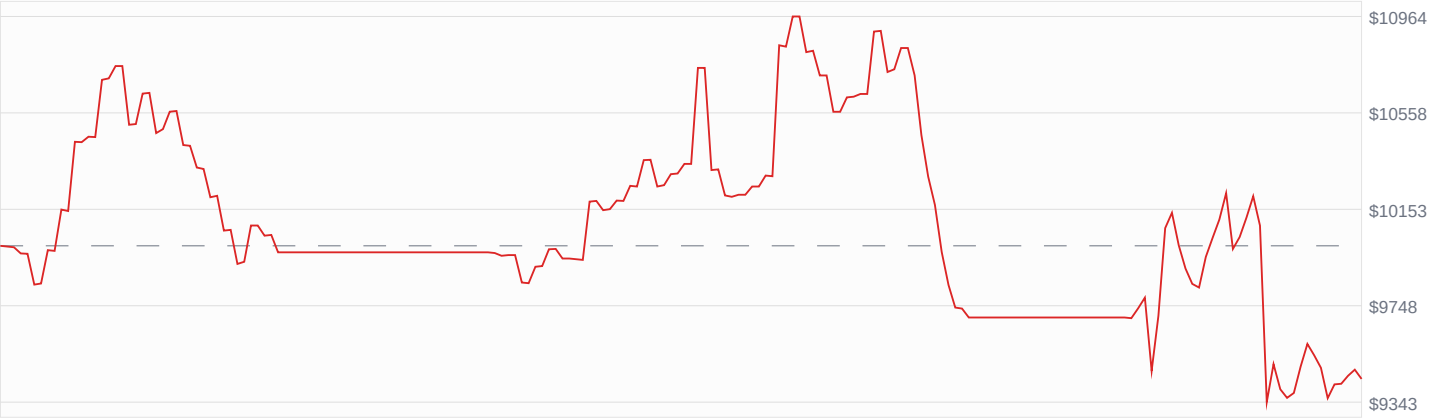

ANALYST NOTE

The backtest for RDN under the EVO_GG1RSISNIP_v1603 strategy is statistically insignificant, showing zero winning trades and a negative Sharpe ratio due to only three executions. The 14.78% peak-to-trough drawdown indicates severe instability when the model does encounter market moves, suggesting a critical flaw in stop-loss placement or entry confirmation. With such a tiny sample size, the -5.59% ROI cannot be generalized to live conditions and likely reflects a single outlier sequence. The strategy must be re-optimized with stricter volatility filters or shifted to a higher timeframe before further deployment.
