



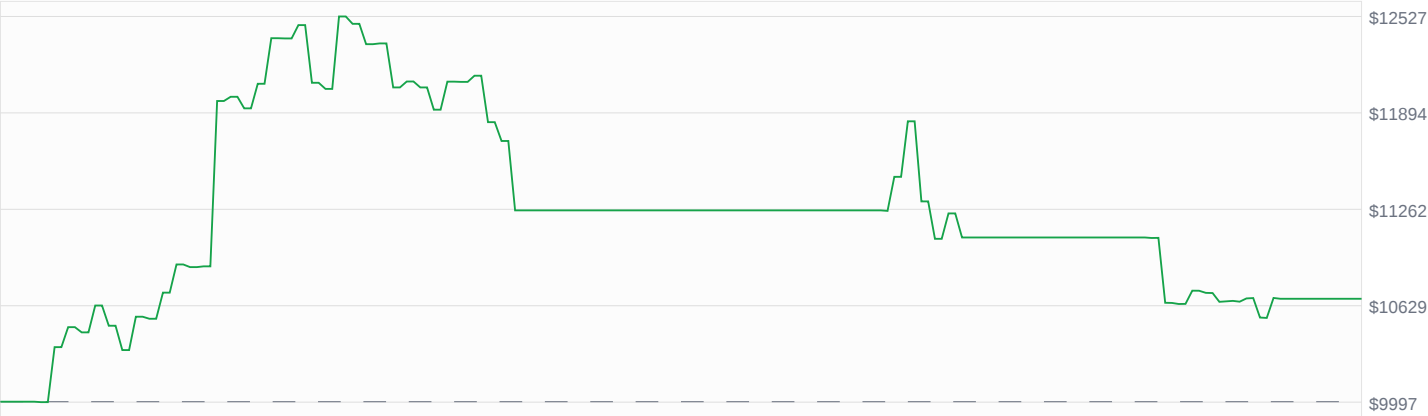

The EVO_GG1RSISNIP_v419 backtest on GOOGL generated a nominal +6.75% return with a Sharpe of 0.54, yet the statistical validity is critically compromised by only three trades. A 33.3% win rate combined with a 15.79% drawdown indicates significant exposure to tail risk rather than sustainable alpha generation. The low trade count renders any performance metrics unreliable and precludes meaningful evaluation of strategy robustness. A minimum of 50 to 100 trades is required to establish statistical confidence before deploying capital. I will run an expanded backtest over a longer historical window to assess parameter stability.
