The EVO_GG1RSISNIP_v345 strategy on AAPL delivered a +10.70% ROI, yet the statistical significance is negligible due to only two executed trades. A 50% win rate and 0.87 Sharpe ratio suggest underperformance relative to risk, while the 11.50% max drawdown indicates high volatility exposure. Without additional trade data, these metrics are likely noise rather than a reliable edge. Increasing trade frequency or widening parameter ranges is necessary to validate if the approach possesses genuine predictive power.
