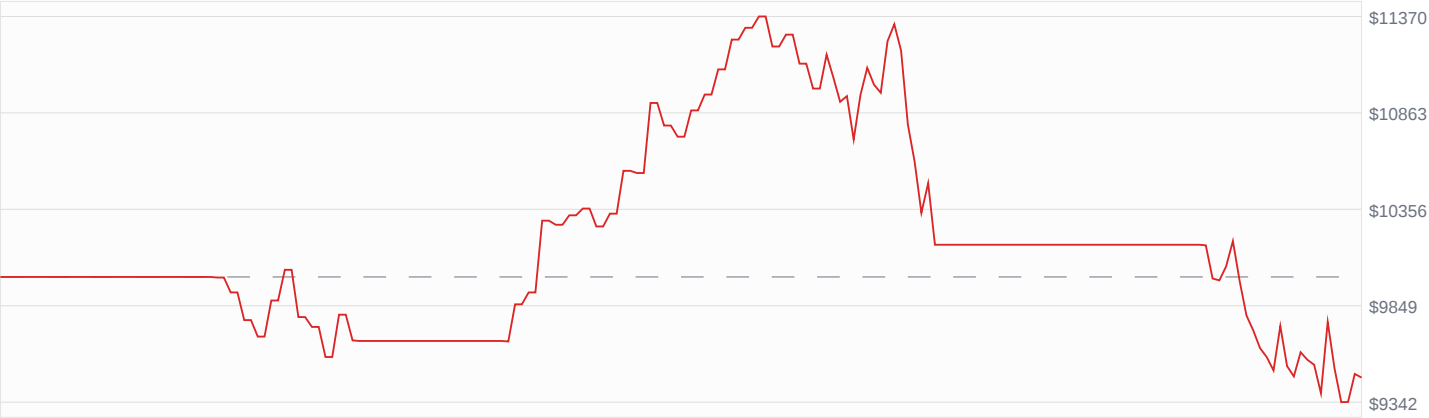

The EVO_GG1RSISNIP_v405 strategy on AMZN produced negative equity with a -5.32% ROI and a Sharpe ratio of -0.36, indicating a complete failure to generate alpha relative to risk-free rates. The sample size of only three trades creates insufficient statistical power to draw valid conclusions about the strategy's robustness or expected performance under normal market conditions. A maximum drawdown of 17.84% suggests significant downside exposure that likely resulted from poor entry timing or inadequate stop-loss placement on a volatile large-cap stock. Given the negligible trade count, any observed win rate of 33.3% is essentially random noise rather than evidence of a flawed edge. The immediate next step is to increase the simulation
