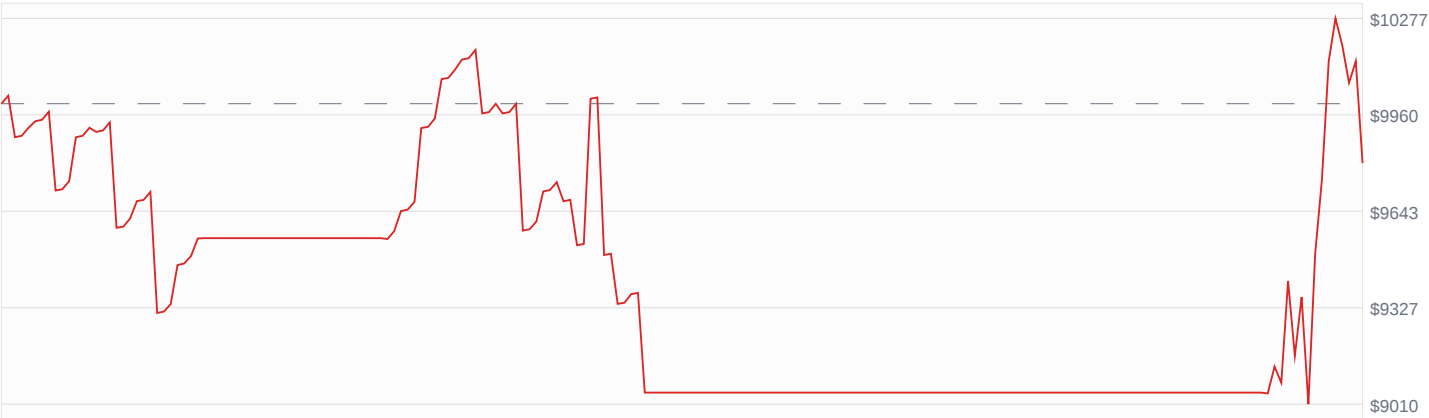

ANALYST NOTE

Hera local LLM

The backtest for VOXR using EVO_GG1RSISNIP_v286 yields a negative ROI of -2.01% and a negative Sharpe ratio of -0.05, indicating a losing strategy over the sample period. With only three trades executed, the win rate of 33.3% and maximum drawdown of 11.32% are statistically insignificant and prone to high variance. The poor performance suggests the strategy fails to capture value or manages risk effectively in current volatility. Immediate next steps require expanding the testing window to accumulate sufficient trades for robust statistical validation.
